

# Private ADHD & ASD Services – Screening, Diagnosis, Coaching & Support Introduction

Every individual with ADHD or ASD experiences the world uniquely. While these neurodevelopmental conditions are often framed in negative terms, they also come with strengths such as creativity, problem-solving, and abstract thinking. Our assessment and support services aim to provide a comprehensive and balanced understanding of each individual's needs and abilities.

# Steps to Screening, Diagnosis, Coaching & Support

## **Step 1: Booking Your Initial Screening**

Email enquiries@adhdnorfolk.org.uk to request a screening or adaptive behaviour assessment. If you're unsure whether ADHD or ASD may be present, we offer a prescreening telephone consultation. Please bring **photo ID for your child** (passport or birth certificate) to the first appointment, for identity verification.

## Step 2: After the Screening

You will receive a screening report within 21 working days, subject to receipt of all required documentation. If documentation is not received within 1 month, a file review fee may apply to reopen the case.

## **Step 3: Progressing to Full Diagnosis**

If your child meets criteria and you wish to proceed: Request a full diagnosis consultation by email. Assessments are conducted by a GMC-registered psychiatrist as part of a multi-disciplinary team. A full diagnostic report is issued and shared with your GP.

## **Medication Guidance (Under 17s – Norfolk Residents)**

We refer eligible Norfolk-based children to the NHS Community Paediatric Service via your GP, following the 2023 Norfolk ADHD protocol.

## **Medication (Under 17s – Outside Norfolk)**

If you live outside Norfolk and medication is considered:

- Your GP must complete a heart sound check and confirm the child is physically fit for treatment.
- Once received, a trial of Atomoxetine (non-stimulant ADHD medication) may be initiated.
- We provide private prescriptions free for 1 year after diagnosis.

- Medication must be purchased from a pharmacy. We do not prescribe stimulant medications.
- Once optimised, we will request shared care prescribing from your GP (who may accept or decline).

## **Step 6: Medication Review**

- 1 year of medication review is included for children outside Norfolk.
- After 1 year: £95 per review appointment.

## **Diagnostic Criteria**

We assess and diagnose in line with: NICE NG87, ICD-11 & DSM-V

These require evidence from multiple domains (e.g. home and school) to establish consistent patterns of neurodivergent behaviour.

## **Supporting Evidence Requirements**

You must provide insight from two separate domains:

- One statement from a family member
- One from an external supportive adult (e.g. teacher, tutor, coach, family friend)

These statements help us assess functioning across environments, in line with NICE guidelines.

## **Document Checklist - Required for ADHD/ASD Assessment**

Document	Description
Developmental History Assessment	Completed by parent/carer.
Parent/Carer Observation Questionnaire	Completed by parent/carer.
Child's Views and Perspectives	Age-appropriate input in child's own words.
Process Doc (This document)	Completed by parent/carer.
Supportive Adult Observation Questionnaires (x2)	From two different non-family adults who know the child well.
Teacher Observation Questionnaire	From someone in an educational setting.
SENDCo Statement	From SENDCo in educational setting.
GP Medical Summary	Must be requested directly by the parent from the GP.

**Important:** Missing documentation beyond 1 month from your screening may incur a re-review fee.

## Non-Use of Al Policy for Supporting Documents

To ensure the accuracy, authenticity, and clinical validity of the information provided:

- All documents submitted as part of the assessment process must be written
  by the individual or their trusted adult contributors, such as parents,
  carers, teachers, or professionals who know the child well.
- Al-generated content (e.g., from ChatGPT, Google Gemini, or similar tools) must not be used to create or complete any observation forms, questionnaires, or written statements.
- Submissions found to contain or be primarily generated by AI may be excluded from consideration, and additional documentation may be requested.
- This policy is in place to maintain the **integrity and reliability of diagnostic decisions**, which are based on genuine observations across environments.

## **Cancellation & Rescheduling Policy**

- Cancellations within 96 hours (4 days) or non-attendance will be charged in full.
- Rescheduling within 4 weeks of your appointment will incur a £150 fee.
